## General Eligibility Norms for seats under NRI/ NRI sponsored Quota

### NRI Category:

The candidates who are claiming under NRI quota shall satisfy the following:

**I.** Applicant shall be the ward of NRI or NRI citizen by him / herself.

**II.** The NRI parent shall be

- a) Holding the OCI/ PIO/ Permanent citizenship status.
- b) Employment in abroad/ Business
- c) Shall have the annual income sufficient to support the course of study of his/her ward.

### NRI sponsored category:

NRI sponsored candidates will be considered subject to fulfillment of the following:

(a) The sponsorer shall be either related to the applicant (i.e., father, mother, brother or their children, sister or their children, maternal uncle or his children, maternal aunt or her children, paternal uncle or his children, paternal aunt or her children, maternal grandfather, maternal grandmother, paternal grandfather and paternal grandmother) (or) willing to sponsor a candidate known to him / her.

(b) NRI status certificate issued by the competent authority.

(c) Copy of the passport with valid VISA.

(d) The sponsorer with student/ visiting VISA or temporary VISA of any nature is **not eligible to sponsor**.

(e) Shall have the annual income sufficient to support the course of study of his/her ward.

An applicant seeking admission under NRI/NRI sponsored quota shall submit application within the prescribed date for conducting counseling for admissions by SKLTSHU.

Non-Resident international citizens of Indian Origin are treated on par with non-resident Indian citizens (NRI/NRI sponsored).

An individual will be treated as a Non-Resident in India in any previous year if he/she has not resided in India for:

- At least 182 days in the year of admission, **OR**
- At least 365 days during 4 years preceding the year of admission **AND** at least 60 days in the year of admission.

An individual who does not satisfy above mentioned conditions will be treated as **Resident Indian**.

## **Biology, Physics and Chemistry (Bi.P.C.) Stream**

### **Eligibility:**

The applicant must have passed 12th standard (English Medium) from an Indian Board or an equivalent Board outside the country of the subjects of Biological Sciences and Physical Sciences for B.Sc. (Hons.) Horticulture (Bi.P.C. stream) NRI/NRI Sponsored quota.

**Criteria for selection:** The selection of candidates shall be based on the merit list prepared on the basis of the marks secured in Intermediate (10+2) or its equivalent. In case of a tie, the marks in the optional subjects viz., Biology/ (Botany, Zoology), Physics and Chemistry shall be taken into consideration and in case of further tie, the age of the candidate shall be taken into consideration and the older candidates shall be given preference.

**General Instructions for Bi.P.C. Stream course:** A good knowledge of English is compulsory. A certificate of the candidate's proficiency in English issued by the respective Indian Mission abroad or recognized agencies should accompany their applications for admission.

**The students seeking admission under the quota are NOT required to appear for any Entrance test (s) of the state or the country i.e., EAMCET or any Common Entrance Test (CET).**

**Age limit for Bi.P.C. Stream course:** The applicant should have completed 17 years of age as on 31<sup>st</sup> December of the year of admission with an upper age limit of 22 years.

**Hostel facility:** Hostel facility shall be provided subject to the availability of accommodation in the respective colleges.

### **Documents to be submitted:**

1. An undertaking by the candidate and parent on stamp paper (Rs. 100/- or equivalent currency) duly notarized (**ANNEXURE-I**).
2. An undertaking by the sponsorer on stamp paper (Rs. 100/- or equivalent currency) dully notarized (**ANNEXURE-II**).
3. Birth Certificate/Proof of Date of birth
4. Higher Secondary (10+2) or Equivalent Examination Mark Sheet
5. Transfer Certificate/Migration Certificate issued by the Head of the Institute/University last attended (whichever is applicable)
6. Bonafide/Conduct Certificate issued by the Head of Institution last attended
7. Medical fitness Certificate
8. Self certification documents of sponsorer showing the proof of NRI status.
9. Work Permit.

10. Business Establishment.
11. Valid Passport of the Financial Sponsor.
12. Valid Visa of the Financial Sponsor.
13. The Bank statement showing the latest transaction of the previous 6 months.
14. **The candidates attending the counseling should bring a demand draft of Rs. 15,222,55/- (Fifteen Lakhs Twenty two Thousand Two Fifty Five Rupees only) in favour of “THE COMPTROLLER, SKLTSHU” payable at Mulugu, Siddpet and Rs. 27,745/- (Twenty Seven Thousand Seven hundred and Forty Five Rupees only) in cash for the immediate payment at the allotted college counter i.e., College of Horticulture, Rajendranagar.**

**Note:**

- **Candidates are required to read the PROSPECTUS thoroughly before applying.**
- The selected candidates under NRI/NRI Sponsored will be treated on par with regular students. No special amenities or facilities will be provided.
- The University will not own the responsibility of the applicant’s involvement in any unlawful activities during the period of study and he/she is solely responsible and shall be required to appear for any enquiry from the police or any other competent authority.
- The candidates admitted under this quota are not eligible for any reimbursement of fee or any other educational concessions offered by the Government.
- The allotment of college shall be based on merit.
- Furnishing of any false information in the application will result in cancellation of admission at any stage.
- **All the rules and regulations governing UG programmes will apply to the candidates selected under NRI/NRI Sponsored quota also.**
- **The unfilled seats under NRI/NRI Sponsored quota will be added to the payment quota and will be filled through counselling.**
- **Fees once paid will not be refunded under any circumstances.**
- Candidates will have to attend for certificate verification at their own cost.
- The applicant is informed that mere submission of an online application and attending for

certificate verification does not automatically guarantee the seat.

- **The University does not guarantee any employment to the candidates.**
- Sri Konda Laxman Telangana State Horticultural University (SKLTSHU) is the only Horticultural University in the State. The University has not accorded any affiliation to any private colleges in Telangana State for B.Sc (Hons) Horticulture Degree Programme.
- The University is not responsible for the information provided in other websites.
- Parents and Students are informed that the admissions are purely based on merit and guidelines of the University and as such they are requested not to rely on any middlemen/persons/consultants who try to mislead the students in securing admission into SKLTSHU under any quota.
